## Bards' Corner

A book review, from our own Simon Maurus of the Argent Quill.

The Middle Ages: An Illustrated History of the Church (ISBN: 0-03-056828-5)

The book was an interesting collection of historical perspectives on the happenings within the Christian Church during the period 900 through 1300 A.D. For the historian, it holds a great wealth of names upon which to do further research. (Something I fully intend to do.) Being illustrated in a style reminiscent of Schoolhouse Rock, it leaves a bit to be desired for the budding costuming enthusiast.

Fifty-nine "chapters' cover everything from the crowing of Otto The Great in 962 to the evangelization of the Far East by the Franciscan John of Monte Corvino. With the promise of such a broad informational scope, it would be easy to take the accounts with full confidence. Yes, here comes the big "but."

Now, I have never claimed any degree of scholarship in the subject, but a factoid listed in chapter 26 of the book raised an eyebrow. Actually, maybe it raised them both. According to the Italian authors:

"In 1118, a monastic order of knights was formed to protect pilgrims going to the Holy Land. In time, the knights became rich and powerful. They were falsely accused of crimes, and the order was destroyed."

So just who were these Boy Scouts, framed when they were only helping little old ladies across the street? The Knights Templar of course! Take the points with a grain of salt, and do a whole lot of fact checking before using this book as a reference.

I will give the author credit, however, for bringing some point of personal interest to the forefront for me. The book gives little ditties such as:

- when the schism in the church began, separating East and West
- particular contributions of individual papal bodies
- the history of the Cistercian monastic order under Bernard of Clairvaux
- papal/imperial political wranglings, etc..

Would I recommend the book to others? I would have to say yes, with the caveat once again that it

should be used as a springboard, and not an authoritative resource.

I encourage everyone to take a shot at reviewing the books in Oldenfeld's library. In the end, it really benefits us all. Enjoy!
